

COMMENT PROCESSING AND TECHNICAL ASSISTANCE INCLUDING ANALYSIS

- **Report Template Development:** Finalize the format of the deliverable templates, confirm the taxonomy for each required activity or forum, and finalize the order for processing extracts for each activity or forum.
- **Comment Review and Categorization:** Download from FDMS, process, triage, track, review, analyze, and summarize every individual comment received using a comment tracker log, including all topic(s) addressed, specifically including the issue and the taxonomy or develop taxonomy as required.
- **Comment Analysis and Summary:** Submit a granular comment log report and usable summaries of comments and analyze the comments to identify themes, sub-themes, patterns, and potential policy conflicts with existing policy.

POLICY ANALYSIS AND RECOMMENDATIONS DEVELOPMENT

- **Policy Analysis Briefing:** Conduct policy analysis through literature research, environmental scans, and identifying proven-effective practices.
- **Policy Analysis White Papers:** Identify and develop recommendations based on policy analysis, understanding of CMS's priorities, the healthcare environment, and the comment processing analysis, and present recommendations in a white paper(s) or other forms as needed.



QUALITY CHECKS OF RULE MAKING ACTIVITIES AND ARTIFACTS

- Provide a thorough review of preamble, regulations, and other text for spelling, grammar, formatting, and correct references and citations, along with accurate nomenclature and appropriateness of response, including tone/sentiment, to public commenters.
